Under the authority granted by SDCL 49-7A-22, the Enforcement Committee of the South Dakota One Call Notification Board met on November 12, 2009 to determine whether there is probable cause that a violation had occurred relative to Complaint OC09-007 filed by South Dakota Network, LLC against Larry's Electric.

By a unanimous vote of the Enforcement Committee, the recommended resolution to the alleged violation included in this complaint was determined to be as follows:

Complaint OC09-007

Alleged Violation of SDCL 49-7A-08 Failure to maintain a minimum horizontal clearance between a marked facility and the cutting edge of any mechanized equipment.

The Committee did not find probable cause that Larry's Electric violated SDCL 49-7A-5 by failing to maintain a minimum horizontal clearance between a marked facility and the cutting edge of any mechanized equipment as required by statute.

Therefore the committee recommends no penalty.

The findings and recommendation of the Enforcement Committee are summarized on the attached form.

Under SDCL 49-7A-27 either party may accept the recommendation of the

Enforcement Committee or reject the recommendation of the Enforcement Committee by requesting a formal hearing on the violation alleged in this complaint.

Under the same statute, failure to respond to this notice is considered acceptance of the Enforcement Committee recommendation and your right to a hearing is waived. Your decision should be reflected on the second page of the attachment with the header "Acceptance or Rejection by Parties". Please return the signed and dated form prior to the close of business on December 3, 2009, to:

If both parties accept this resolution, the South Dakota One Call Notification Board is required to accept the resolution and close this complaint. If either party rejects the Enforcement Committee resolution of the alleged violation, the South Dakota One Call Notification Board will conduct a hearing as a contested case under Chapter 1-26 to resolve the allegation alleged in the rejected complaint. Following this hearing, the Board shall either render a decision dismissing the complaint for insufficient evidence or shall impose a penalty pursuant to SDCL 49-7A-18 or SDCL 49-7A-19.

Pursuant to SDCL 15-6-55, failure to answer this Complaint could result in a default judgment being issued against you. Appropriate liens and other legal collection actions could result. You are strongly urged to reply to this Notice in the time frame described above and to obtain the advice of counsel should you have any legal questions.

ENFORCEMENT COMMITTEE ACTION

South Dakota Network, LLC vs. Larry's Electric

FINDINGS:

OC09-007

Alleged Violation of SDCL 49-7A-5 Notification of Proposed Excavation

Allegation is made by South Dakota Network, LLC that Larry's Electric failed to maintain a minimum horizontal clearance of eighteen inches between a marked underground facility and the cutting edge of any mechanized equipment at a location in front of the State Library on August 26, 2009 as required by SDCL 49-7A-08.

Mr. Harris stated that neither he nor any employee of Larry's Electric had any involvement in this complaint.

In reviewing the complaint filed by South Dakota Network, LLC and the response from Larry's Electric, the committee did not find evidence to support probable cause that Larry's Electric violated SDCL 49-7A-08.

RECOMMENDATION

OC09-007

VIOLATION OF SOUTH DAKOTA SDCL 49-7A-08:

The Committee did not find probable cause that Larry S. Electric had violated SDCL 49-7A-08 by failing to maintain a minimum horizontal clearance of eighteen inches between a marked underground facility and the cutting edge of any mechanized equipment at a location in front of the State Library on August 26, 2009 as required by SDCL 49-7A-08.

PROPOSED PENALTY FOR THIS VIOLATION AUTHORIZED UNDER SDCL 49-7A-18:

The committee recommends no penalty due to lack of probable cause.
