### South Dakota One Call Notification Board Enforcement Panel Conference Call

The Enforcement Panel of the South Dakota One Call Board will meet to consider the following South Dakota One Call Complaint:

**OC12-017 – In the Matter of the Complaint filed by Montana-Dakota Utilities Company, Rapid City, South Dakota, Against Zandstra Construction, Rapid City South Dakota for an incident occurring on November 21, 2012 at the intersection of E. Minnesota and Fieldstone Dr., in Rapid City, South Dakota.**

On December 12, 2012, Montana-Dakota Utilities Company filed a complaint against Zandstra Construction, alleging that Zandstra Construction dug without a valid South Dakota One Call locate. Scott Zandstra from Zandstra Construction responded on December 20, 2012 and did not dispute the allegation. He stated that they will call in locates before digging and that this will not happen again.

**Today, shall the Enforcement Panel of the South Dakota One Call Notification Board find that there is probable cause that Zandstra Construction violated any statute or rule under the jurisdiction of the Board, and if so shall a civil penalty be assessed?**

Only the written information provided by the Complainant and the written response from the defendant will be considered per SDCL 49-7A-25. No comments from either party involved in the complaint will be taken during this call.
