**ORDER ADOPTING
ENFORCEMENT PANEL
RECOMMENDATION TO THE SD
ONE CALL BOARD AND TO
PURSUE COLLECTION ACTION
IF NECESSARY**

On October 22, 2015, the South Dakota Public Utilities Commission received a complaint from Humboldt Municipal Gas Utility (Humboldt) against Construction Signing Corporation (CSC). The complaint alleges that on or about September 26, 2015, Respondent engaged in excavation and damaged a 2" gas line when moving mailboxes without making locate requests. A copy of the complaint was sent to Respondent on October 22, 2015. Respondent did not respond to the Notice of Complaint by the November 12, 2015 deadline.

On November 24, 2015, pursuant to SDCL 49-7A-22 a panel of five One Call Board members (Panel) convened. The Panel met to determine whether probable cause exists to believe the violation occurred as described in the complaint. The Panel found sufficient evidence was presented to determine probable cause exists to believe a violation of SDCL 49-7A-5 occurred. The Panel did not find the violation to be intentional.

The Panel found it proper to assess a penalty of \$1000.00 with \$500.00 suspended on certain conditions as listed below.

The recommended suspension conditions are as follows:

- i. Respondent shall make payment of the \$500.00 unsuspending portion of the penalty within thirty days of issuance of the final SD One Call Board Order.
- ii. Payment shall be remitted to: South Dakota Public Utilities Commission, 500 E. Capitol Ave., Pierre, SD 57501.
- iii. Respondent shall attend a damage prevention seminar in the spring of 2016.
- iv. Respondent shall conduct an in-house safety meeting with its subcontractor to review the One Call laws. The meeting shall be held within 30 days of the final One Call Order, unless such meeting has occurred prior to the issuance of the Order, but subsequent to the violation. Documentation shall include the printed and signed names of meeting participants, details of the material discussed, and the date and length of the meeting. Documentation shall be submitted to the Executive Director of South Dakota One Call within that 30 day period.

- v. Respondent must not be found to have committed another violation of a One Call rule or regulation within the 12 months of the SD One Call Board Order.

If any of the conditions are not met, the entire \$1000.00 Penalty will be immediately due and owing.

At its regularly scheduled meeting on February 10, 2016, the South Dakota One Call Board, pursuant to 49-7A-27, reviewed the Panel's procedure and approved its findings.

It is therefore:

ORDERED, that the South Dakota One Call Board adopts the recommendations of the Panel as a final resolution of this complaint. The Panel's findings are attached hereto and shall be considered fully incorporated herein; it is further

ORDERED, that if the penalty is not paid, the Board shall pursue any rights it has under the law regarding collection; it is further

The South Dakota One-Call Notification Board has jurisdiction in this matter pursuant to SDCL Chapters 1-26 and 49-7A, specifically SDCL 49-7A-5, 49-7A-18, 49-7A-20, 49-7A-22, and 49-7A-26.


