

The Enforcement Panel of the South Dakota One Call Board will meet by conference call to consider the following South Dakota One Call Complaints:

**OC16-010 – In the Matter of the Complaint Filed by Montana-Dakota Utilities (MDU), Spearfish, South Dakota, Against New Way Builders (New Way), Pine Haven, Wyoming, for an Incident Occurring on July 22, 2016, at Split Rock Rd, Sturgis, S.D**

**On August 31, 2016 MDU filed a complaint against New Way, alleging that New Way dug without requesting a locate ticket, which resulted in the damage of a 2", 25 psi gas line being cut.**

**At this time, New Way has not responded to the Complaint.**

**Today, shall the Enforcement Panel of the South Dakota One Call Notification Board find that there is probable cause that New Way violated any statute or rule under the jurisdiction of the Board, and if so shall a civil penalty be assessed?**
