

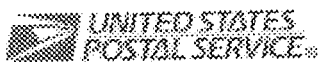
The Enforcement Committee recommendation to resolve Complaint OC05-007 has been accepted by both parties involved in the complaint. The order closing this Complaint is attached.

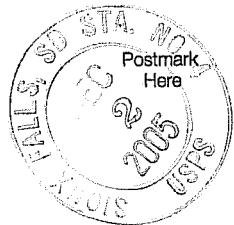

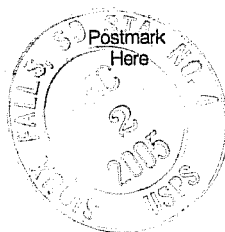
