A Request for Deputy Director, RFP #1793, was posted to the South Dakota 811 and Office of Procurement websites on August 15, 2019 and closed on September 15, 2019. A selection committee consisting of South Dakota One Call Board Members, Fay Jandreau, Doug Larson, Bleau LaFave, Erin Hayes, and Kevin Kouba met by conference call on September 23, 2019 to discuss the RFP and unanimously agreed on a candidate recommendation. The candidate was presented to the Board at the October 1, 2019 Board of Directors Meeting. Today shall the Board enter into a contract with the candidate, and with what terms? The Board did not go into executive session. Lloyd Rave made a motion to enter into a contract with Codi Gregg for the position of Deputy Director.
