The Enforcement Panel of the South Dakota One Call Notification Board will meet to consider the following South Dakota One Call Complaints:

OC119-001 – In the Matter of the Complaint filed by Montana Dakota Utilities (MDU), Rapid City, South Dakota against Zandstra Construction, (Zandstra) Rapid City, South Dakota for an incident occurring on February 12, 2019 at Elysia Court, Rapid City, South Dakota.

Deadline to Respond was March 13, 2019. No response was received by Zandstra.
Previous Complaint history: 2012 Issued a \$1,000 with \$500 suspended.
